Residents meeting the eligibility requirements for the first time will also receive a one-off Incentive Basic Funds of 10,000 patacas.

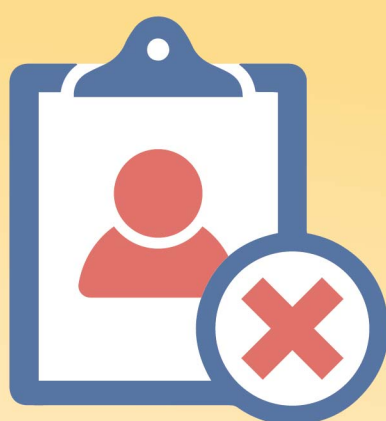

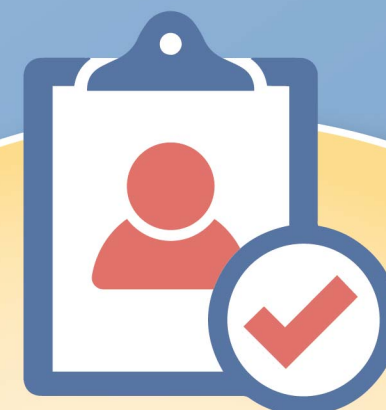

### Exclusion from the List

Persons who, for statutory reasons, have resided in Macao for fewer than 183 days in 2025 may submit a statement of objection.

The following reasons can be processed through the  Macao One Account:

- ▶ Attending a tertiary education programme outside Macao
- ▶ Hospitalisation
- ▶ Attained age 65 and habitually residing in the Chinese Mainland
- ▶ Under age 65 and residing in the Chinese Mainland due to illness
- ▶ Posted to work outside Macao by a Macao employer
- ▶ Working outside Macao to bear the living expenses of relatives residing in Macao or in the Guangdong-Macao In-Depth Cooperation Zone in Hengqin
- ▶ Residing, working, or attending a tertiary or non-tertiary education programme in the Guangdong-Macao In-Depth Cooperation Zone in Hengqin
- ▶ Official duties

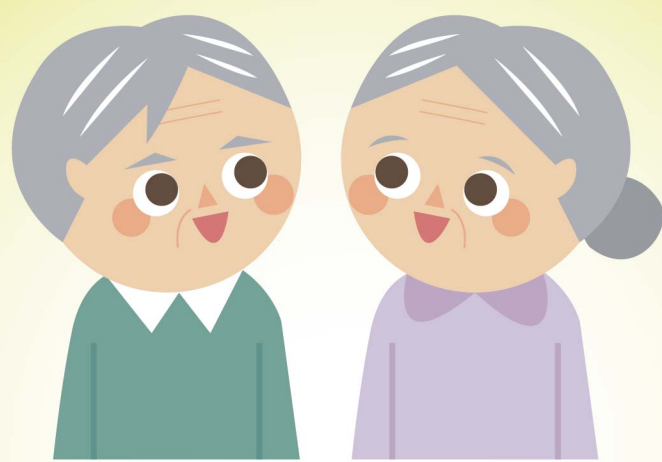
