### 2 To be eligible for this allocation, an individual must meet all three of the following criteria:

- ▶ Be a Macao permanent resident aged 22 or older in 2024 ;
- ▶ Be alive on 1 January 2025 ; 
- ▶ Have been present in Macao for at least 183 days in 2024 .

First-time eligible residents will receive a one-time incentive basic funds of **10,000 patacas** at the same time.

**Individuals who spent less than 183 days in Macao during 2024**

due to a statutory reason may file an objection statement.

The following individuals can file an objection statement via the  **Macao One Account**:

- ▶ Attending tertiary education courses outside Macao
- ▶ Hospitalisation
- ▶ Residing in the Chinese Mainland and
  - ▶ has reached 65 years of age
  - ▶ aged below 65 and in need of medical treatment or family care due to health reasons
- ▶ Working outside Macao for an employer registered with the Social Security Fund
- ▶ Working outside Macao in order to bear the main living expenses of their families residing in Macao
- ▶ Performing public service duties or holding positions for serving the Macao SAR or performing other official duties
