I declare that I am aware that contributions to the Arbitrary System are voluntary and that contributions paid in accordance with the law are non-refundable. I further acknowledge the following:

1. Beneficiaries under the old system (enrolled before 1 January 2011): Once the contribution requirements for the old-age pension have been met (at least 60 months of contributions), or after the commencement of old-age pension payments, the pension amount shall not be adjusted if contributions under the Arbitrary System continue, but entitlement to other social security benefits shall remain. In such a case, the old-age pension and sickness allowance shall not overlap under the law, but the beneficiary may opt for whichever benefit is more advantageous.
2. Beneficiaries under the new system (enrolled on or after 1 January 2011): The old-age pension amount is calculated proportionally by dividing the actual number of contribution months by 360. After pension payments begin, if contributions under the Arbitrary System continue, the pension amount may be adjusted each April until a total of 360 contribution months is reached. At the same time, continued contributions shall maintain entitlement to other social security benefits. In such a case, the old-age pension and sickness allowance shall not overlap under the law, but the beneficiary may opt for whichever benefit is more advantageous.

1. Should you wish to start or suspend payment of contributions under the Arbitrary System in the future, you must make an application to the Social Security Fund.
2. Each benefit is subject to specific contribution requirements. For example, marriage, birth and sickness allowances require at least nine months of contributions within the twelve months preceding the quarter in which the event occurs. To safeguard social security entitlements, it is advisable that you contribute in accordance with your own circumstances and regularly review contribution records through "Macao One Account".
