All Service Points of FSS	Pay in cash, by cheque or cashier order (payable to "Fundo de Segurança Social")
Public Services Centres of IACM	Pay in cash, by cheque or cashier order (payable to "Instituto para os Assuntos Cívicos e Municipais")
Designated Banks (Payment Counter)	Pay in cash, by cheque or cashier order (payable to "Fundo de Segurança Social") (the designated banks only accept cheques or cashier orders of their own banks)

Designated banks include the Bank of China Macau Branch, Industrial and Commercial Bank of China (Macau) Limited, Banco Comercial de Macau S.A., Tai Fung Bank Limited, Banco Nacional Ultramarino S.A., OCBC Wing Hang Bank Limited, The Macau Chinese Bank Ltd., Luso International Banking Limited and Delta Asia Bank Limited.
