## Payment Methods

Location	Methods
All Service Points of the FSS	Pay in cash, by cheque or cashier's order (payable to "Fundo de Segurança Social"), bank card, UnionPay QuickPass, UnionPay App, BoC Pay, MACAU Pass Card or MPay
Municipal Affairs Bureau's Public Services Centres and its sub-stations	Pay in cash, by cheque or cashier's order (payable to "Instituto para os Assuntos Municipais"), or pay by UnionPay QuickPass Card or MACAU Pass Card
Designated Banks (Payment Counter)	Pay in cash, by cheque or cashier's order (payable to "Fundo de Segurança Social") (the designated banks only accept cheques or cashier's orders of their own banks)

NOTE:

1. Contribution period: (contributions for long-term employees/arbitrary system contributions/employment fee for non-resident workers) contributions for the preceding quarter are paid quarterly in January, April, July and October; (contributions for casual workers) contributions are paid in the month that immediately follows the employee's work month.
2. For the locations of service points of the FSS, the Municipal Affairs Bureau's Public Services Centres and its sub-stations, the branches/sub-branches of designated banks, and the set-up locations of the self-service equipment of designated banks, please visit the websites of the FSS or the related banks.
3. Municipal Affairs Bureau's Public Services Centres and its sub-stations, and designated banks only accept FSS' **payments that are made on time**.
4. Designated banks include the Bank of China Macau Branch, Industrial and Commercial Bank of China (Macau) Limited, Banco Comercial de Macau S.A., Tai Fung Bank Limited, Banco Nacional Ultramarino S.A., OCBC Wing Hang Bank Limited, The Macau Chinese Bank Ltd., Luso International Banking Limited and Delta Asia Bank Limited.
5. Only applies to online banking and ATMs of Jetco Network provided by the Bank of China Macau Branch, Industrial and Commercial Bank of China (Macau) Limited, Banco Comercial de Macau S.A., Tai Fung Bank Limited, Banco Nacional Ultramarino S.A. and OCBC Wing Hang Bank Limited.
6. Only applies to the Bank of China Macau Branch.
7. You need to pay with your UnionPay QuickPass or MACAU Pass Card.
