2. 僱主不在法定期限內繳納供款,須支付遲延利息,其每月利率為所欠供款總額的百分之三計算,不足一個月亦按一個月計算。如利息金額少於澳門幣五十元,則按澳門幣五十元徵收,遲延利息於繳納所欠供款時同時繳納。〔同一法律第二十一條第一款及第二十二條〕An employer who fails to pay contributions within the statutory period is liable to a late payment interest. The monthly interest rate is 3% on the total amount of contributions in arrears, where a fraction of a month shall be counted as a full month. An interest of 50 patacas shall be levied if the amount of interest calculated is less than 50 patacas. The late payment interest should be paid together with the contributions in arrears. (Articles 21(1) and 22 of the same law)

The contributions of the preceding quarter are paid, on a quarterly basis, in January, April, July and October of each year. For work provided under term labour contracts, contributions should be paid in the month that immediately follows the employee's work month. (Articles 12, 15, 16 and 19(3) and (4) of

- 3. 倘僱主不在法定期限內進行註冊或為僱員登錄,按違法行為所涉及的每一僱員,可被科處澳門幣二百元至一千元的罰款。〔同一法律第六十一條第一款(一)項及(二)項〕If an employer fails to register with the FSS or enrol the employees within the statutory period, he/she will be liable to a financial penalty of 200 to 1,000 patacas for each employee affected by his/her infractions. (Article 61(1)(a) and (b) of the same law)
- 4. 在有關期限屆滿的六十日後仍不繳納其負責繳納的供款,可被科處不超過所欠供款金額一半的罰款,但最低為澳門幣五百元。〔同一法律第六十一條第二款〕An employer, who fails to pay contributions for which he/she is responsible after 60 days from the expiry of the relevant period, shall be liable to a fine of up to half of the amount of contributions in arrears, but the minimum amount is 500 patacas. (Article 61(2) of the same law)
