POINTS TO NOTE

If an account owner dies, the balance of his/her individual account and the amount he/she is entitled to receive under the law will be included in his/her estate. The administrator of the account owner's waiting-to-be-divided property or the legitimate heir(s)^{NOTE} can apply to withdraw the balance of the said individual account.

NOTE: If the account owner has more than one legitimate heir, the applicant can submit the *Power of Attorney from Heirs for the Withdrawal of Funds (Form H/1)*, authorizing one or more of the heirs to apply for the withdrawal of funds and to receive the money on their behalf.

DOCUMENTS REQUIRED TO BE SUBMITTED

- 1. Photocopy(ies) of identification document(s) of the legitimate heir(s);
- 2. Photocopy of the notarial deed or the judicial proof that shows the determination of heirship (required to produce the original for verification). If it is indicated in the above notarial deed that there is a notarial will, the applicant is also required to submit a photocopy of the notarial will (required to produce the original for verification);
- 3. Photocopy of the death certificate of the deceased individual account owner;
- 4. Photocopy of the applicant's bank account in patacas.
