- NOTE:
1. In the case where the labour relationship is not terminated, the account owner can only withdraw the contribution balance that belongs to him or her in the contribution sub-account.
 2. The account owner can withdraw the employer's contribution balance only if the labour relationship has been terminated. Only after the employer has paid the last contributions for the employee within the month following the termination of labour relationship and the related fund management entity has completed the fund settlement procedure can the Social Security Fund process the fund withdrawal application.
 3. If the above-mentioned contribution sub-account relating to the termination of labour relationship has been cancelled and the balance has been transferred to other sub-account, the sub-account that has been transferred with funds will be considered by the Social Security Fund as the settlement account for this fund withdrawal application, and the sub-account will be settled according to the settlement order and withdrawal amount filled in by the applicant.
