- ✓ The declarant is required to submit a photocopy of his or her valid Macao SAR Resident ID Card, the original of a personally signed Objection Statement (RP), and the original declaration form.
- I. For account owners who attended higher level courses recognized by the local competent authority

Transcript(s) or the proof of school attendance for the period from January to December of the calendar year preceding the year of fund allocation, issued by the school or printed online in the year of fund allocation. The transcript or school attendance must contain the school name, the account owner's full name (must match the name on the ID card), the student ID number, period of school attendance, name of major/faculty (must be a higher education course recognized by the local competent authority).

Student IDs or tuition bills are not accepted. (If the programme is completed between January and December of the calendar year preceding the year of fund allocation, please submit a photocopy of the relevant diploma.)

II. For account owners who were hospitalized

The proof of hospitalization issued by a local hospital for the calendar year preceding the year of fund allocation must indicate the patient's full name, period of hospitalization and the hospital seal and date of issue.

- III. For account owners who worked outside the Macao SAR for an employer registered with the Social Security Fund
 - 1. Declaration Form (C/3) completed by the employer or the person in charge.
 - Proof of business operations for the employer outside Macao for the calendar year preceding the year of fund allocation, e.g. Business Tax bills and annual reports, which must either be issued by a local government or bear a government seal.

- V. For account owners who worked outside the Macao SAR to bear the main living expenses of his or her spouse, any degree of lineal consanguinity or affinity who resided in the Macao SAR
 - 1. Fill out the Declaration Form (C/6).
 - A photocopy of the dependent relative's Macao SAR Resident ID Card and a photocopy of the proof of kinship with the account owner.
 - 3. Evidence of payment for the dependent relative's main living expenses (e.g. remittance slip of the year preceding the year of fund allocation must show the full names of the account owner and dependent relative). Suppose the account owner is unable to provide any supporting documents. In that case, two Macao SAR residents must be provided as witnesses (witnesses must sign and testify), and photocopies of their Macao SAR Resident ID Cards must be submitted.
 - 4. The proof of employment letter for the account owner:
 - 4.1. For employed workers, the proof must be issued by a local employer, indicating the account owner's identity information, the period of employment and the position held, and the name and address of the company.
 - 4.2. For people who run their own businesses, or self-employed persons, the business licence and proof of business operations for the calendar year preceding the year of fund allocation must be provided, e.g. Business Tax bills and annual reports, which must either be issued by the local government or bear a government seal (if the business is a limited company, documents proving the identity of the shareholders for the calendar year preceding the year of fund allocation must also be submitted).
 - If the dependent child was attending school in Macao, the transcript(s) or the proof of school attendance for the period from January to December of the calendar year preceding the year of fund allocation must be provided.
 - 6. If the dependent child was attending a high school or university outside Macao, the account owner must also provide photocopy(ies) of the child's transcript(s) or diploma(s) for the junior high school and high school in Macao besides photocopy(ies) of the transcript(s) or the proof of school attendance (please refer to Point I for the requirements of the content) for the period from January to December of the calendar year preceding the year of fund allocation. If the dependent relative is hospitalized outside Macao, the proof of hospitalization must be submitted (please refer to Point II for the requirements of the content).

VI. For account owners who performed official duties, performed duties for the Macao SAR, or discharged other official duties Fill out the Declaration Form (C/8), and submit documents related to the account owner's performance of duties or discharge of official duties outside Macao in the calendar year preceding the year of fund allocation.

VII. For account owners who had humanitarian or other properly explained reasons

Fill out the Declaration Form $(C/7)^{Note}$, describe in detail the reason for staying in Macao for less than 183 days in the calendar year preceding the year of fund allocation. Note: If you are living in the Guangdong-Macao In-Depth Cooperation Zone in Hengqin on or after 1 March 2023, fill out the Declaration Form (C/7-A) and submit the supporting documents listed in the declaration form.

VIII. Self-declare to have been in the Macao SAR for at least 183 days in the calendar year preceding the year of fund allocation Fill out the Declaration Form (C/9), describe in detail the period of residence, life, and work in Macao in the calendar year preceding the year of fund allocation, and submit relevant supporting documents.

POINTS TO NOTE

- 1. Please verify that each form has been duly completed and signed (must match the signature on the ID card). The form can be submitted to the Social Security Fund or a service point by yourself or others.
- 2. The Objection Statement form, various declaration forms, and supporting document templates can be downloaded from the Social Security Fund's website at www.fss.gov.mo, or obtained from a service point.
- 3. If the account owner is **incapacitated**, besides filling out this objection statement, the person acting on his or her behalf is required to fill out the Declaration Form (C/2) as well, and submit all relevant supporting documents.
